

# A MESSAGE FROM OUR CHAIR AND OUR EXECUTIVE DIRECTOR

Dear Friends,

lowa Rivers Revival's growth and successes are boundless – much like the thousands of miles of rivers and streams that run through this state – especially when driven by passionate and dedicated volunteers and supporters who are invested in river quality and conservation.

IRR is committed to developing a statewide river network, a unified voice, to improve lowa's water quality and preserve our unique riverscapes. Looking back over 2009 I realize that this was IRR's first 'real' year as an organization. We developed and carried out a full agenda of activities and priorities, including legislative advocacy, educational outreach, a major gifts fundraising campaign to sustain our budget needs and key networking to build statewide support. Activities, outcomes and relationships continue to affirm the need for a statewide river group.

As an organization our progress is commendable; however, the condition of and consideration for lowa's rivers are deplorable. An ever-shrinking state budget that fails to prioritize natural resources interests and a complacent public attitude are growing threats to lowa's river conditions and water quality. Together we can change course and ensure future generations will experience "clean, free-flowing lowa rivers teeming with life..."

# Clean Water · Quality of Life Community & Economic Enhancement

Dear Supporters, Donors, Colleagues and Friends,

Our successful year of 2009, described in this annual report, will provide a solid foundation for building the capacity of our organization in 2010. We will strengthen our statewide network of supporters to increase appreciation and protection of lowa's rivers. We will encourage people to enjoy our rivers and help connect people and communities. Our network will reach the Missouri and Mississippi Rivers as well as smaller rivers and streams.

The most important political issue for rivers in 2010 will be passage of the Natural Resources and Outdoor Recreation Trust Fund constitutional amendment. Conservation spending in Iowa has long been under funded and subject to diversion to other uses. Approval of the amendment in the November general election will allow the Legislature to dedicate a funding stream for a permanent boost in conservation investment.

I am proud of the achievements noted in this report; we have come a long way in four years. Making the best use of the resources our supporters have given us, both funding and time, is very important to me. Thank you all for your support, and keep letting us know your ideas.

#### HISTORY OF NONPROFIT — GROWTH

In March 2006 a coalition of individuals, state agencies and nonprofit organizations sponsored and organized the inaugural "lowa Rivers Revival" conference where the need for a statewide organization committed to river advocacy, conservation and education was identified. Following the inaugural conference, a dedicated, core group of volunteers continued to meet monthly to develop the mission and vision for a new statewide river organization and an agenda of programs and priorities to protect and enhance lowa's rivers. lowa Rivers Revival was officially incorporated by the state of lowa as a non-profit in November 2006 and received federal non-profit status in March 2009.

After nearly four years, IRR continues to flow and grow due to the generous support and contributions of our river communities and friends and on behalf of ever-increasing awareness and interest in the quality and condition of lowa's rivers and streams.

lowa Rivers Revival is the statewide river advocacy group committed to protecting some of our most precious natural resources — our rivers and streams. IRR is working to engage individuals, organizations, communities and government leaders in river awareness, responsibility and enjoyment in an effort to improve and enhance the condition of lowa's waterways — ensuring a quality, safe and lasting resource for future generations.

#### 2009 ACCOMPLISHMENTS

#### **Education/Outreach**

- Held 4th Annual Conference-Annual Banquet-River Town of the Year Award-Live Auction, Webster City, Iowa – May 2009
- Launched IRR's River Rascals program in June 2009, to provide urban youth a river experience including instruction on paddling, water safety, river etiquette, river biology and river issues such as water quality/water monitoring, while having FUN!
- Initiated planning of Master River Steward Program continuing to develop a program to connect individuals and communities to lowa's rivers by providing opportunities for children, families and members of the public to learn more about the importance of rivers and problems associated with them.
- Continued outreach to increase awareness about river issues, including quality, conditions, opportunities and responsibility.

# **Advocacy**

- ☑ Held Legislative Reception February 2009
- Organized Lobby Day February 2009; established a vigorous, unified presence and voice for lowa's rivers.
- Worked with Senator Bolkcom to successfully advocate for passage of SF263 (signage bill) in the Iowa Senate. In the interest of public safety and awareness, this bill would require National Discharge Elimination System (NPDES) permit holders that discharge into a stream or river to post a sign at the discharge point with permit and contact information.
- Increased awareness about Iowa's Water and Land Legacy campaign in support of the Natural Resources and Outdoor Recreation Trust Fund.



#### RIVER RASCALS


