**PURPOSE:** The *River Town of the Year Award* celebrates the many vibrant river communities across lowa reclaiming riverfronts as anchors for economic development, recreation, ecological practices, and improving the safety and quality of lowa's rivers. lowa Rivers Revival is a statewide non-profit leading lowans to protect, restore, and enjoy our rivers.

**WHO CAN APPLY:** Any lowa city or town can apply. Organizations are also encouraged to provide a nomination on behalf of any lowa city or town. **Nomination deadline is Thursday, September 1, 2022**.

**AWARD:** One lowa river town will receive the *River Town of the Year Award* in the spring of 2021 at a reception hosted by lowa Rivers Revival in the award-winning town. Local, regional, and statewide recognition is earned through media and public awareness efforts. Applicants must demonstrate community commitment and involvement in protecting and maintaining river quality and promoting the river as an asset to the town.
